

ChipSync Community Guidelines

Welcome to ChipSync®! These Guidelines explain how to participate respectfully in our community. They are part of our Terms & Conditions, and violating them may result in warnings, suspension, or removal from the App.

Our goal is to create a safe, fun, and respectful space where people can enjoy poker nights, share photos, track results, and connect with friends. Failure to comply with these Community Guidelines constitute a breach of our Terms of Use and may result in suspension or cancellation of your account or being reported to authorities.

1. Be Respectful

- Treat all users with courtesy. No harassment, hate speech, threats, bullying, or personal attacks.
- Respect different skill levels and experiences. Poker is competitive, but our community is collaborative.

2. Keep Content Appropriate

- **Allowed:**
 - Photos of games, chips, tables, group fun, and casual social moments.
- **Not Allowed:**
 - Nudity, sexually explicit content, excessively violent images, or any illegal activity.
 - Do not share content that is discriminatory, hateful, or harmful.
 - Prostitution, Sex, and Human Trafficking: You are not allowed to reference, promote, support, discuss, or share any content involving Prostitution or Sex or Human Trafficking.

3. No Illegal Gambling Facilitation

- Different states have different laws concerning private poker games. You are responsible for using this App in a manner that does not violate the state or local law of your residence. Utilizing this App in a manner that violates state or local law of your residence is a violation of our “Terms and Conditions” and “Community Guidelines.”

- You may use the App to **track** buy-ins, cash-outs, and stats.
- You may **not** use the App to arrange or transfer real money, bets, or gambling transactions.
- The App is strictly for private entertainment and recordkeeping purposes.

4. Protect Privacy

- Share photos responsibly. Only post images you have the right to share and that respect others' privacy.
- Do not share personal information of others (addresses, phone numbers, financial details, etc.).

5. No Spam or Misuse

- Do not send spam, promotional content, or repetitive unwanted messages.
- Do not attempt to hack, exploit bugs, scrape data, or interfere with the App's operation.

6. Age Requirement

- You must be at least **18 years old**.
- If we discover any account created by an individual under the age of 18 years of age, we will delete the account.

7. Play Fair

- Do not create fake accounts, impersonate others, or manipulate leaderboards.
- Respect group rules set by your community organizers.

8. Enforcement

- We reserve the right to remove content, issue warnings, suspend accounts, or permanently ban users who violate these "Community Guidelines" or our "Terms and Conditions."
- Repeated or severe violations may result in permanent removal.
